- The 2011-2012 Budget estimate of 1.5 per cent growth in real GDP in the New Brunswick economy is still valid, and comparable to the latest survey of private sector forecasters.
- Since January 2007, New Brunswick's population has increased in 16 of the last 17 quarters.
- New Brunswick's labour force is contracting in 2011 with employment falling by 6,000 so far this year. Gains in part-time employment have not been enough to offset full-time losses.
- Job losses are greatest in trade (-4,200), education (-1,800) and other services (-1,800).
- Growth in exports and manufacturing sales in New Brunswick has been among the strongest in the country so far in 2011, largely as a result of rising world energy prices.
- Retail sales have shown healthy growth so far this year, up 4.5 per cent, outpacing the national increase of 3.3 per cent.
- Consumer inflation in the province has averaged 3.2 per cent, slightly higher than the national growth rate of 2.9 per cent.

2011-2012 Fiscal Update

Based on first quarter information, a revised deficit of \$514.3 million is projected for 2011-2012. This is an increase of \$65.5 million compared to the budget estimate of \$448.8 million.

Net debt is projected to increase \$678.4 million year-over-year, an increase of \$48.2 million from budget.

Revenues are currently tracking on budget with a slight increase of \$1.1 million. There are only a few material variances:

- Lottery revenues are down \$8.2 million due to several factors including higher than anticipated payments to First Nations, lower than anticipated profits for Atlantic Lottery Corporation and lower casino revenues projected.
- *Motor Vehicle Act* fees are up \$7.4 million due to an increase in volume for motor vehicle registrations.
- Special Operating Agency funding is up \$1.5 million mainly due to various funding agreements within the Regional Development Corporation.

Expenses are \$66.6 million higher than budget. Contributing factors include:

- \$19.2 million increase in the Department of Health mainly due to higher than anticipated expenditures within the Prescription Drug Program and the Regional Health Authorities.
- \$37.1 million increase in General Government primarily due to increases in pension expense and provision for losses.
- \$9.1 million increase in the Department of Social Development mostly due to additional expenditures in the Income Security Program.

These expenses are partially offset by a number of under-expenditures, including a decrease in the Department of Transportation due to the recognition of rehabilitation payments under public-private partnerships as investments in tangible capital assets.
