

WEEKLY NEW BRUNSWICK INFLUENZA REPORT

Reporting period: April 1, 2012 – April 7, 2012 (week 14)

Summary

In New Brunswick, continued increase (since week 11) in percent positive lab results

New Brunswick:

- There have been 39 positive influenza detections during week 14, 1 influenza A (H1N1) pdm09 and 38 influenza B.
- The ILI consultation rate was low and is below the expected range for this time of year.
- 4 new ILI school outbreaks were reported.

Canada:

- Overall Influenza activity continues to decline; however activity remains elevated in some regions of the country (i.e. Atlantic Region, Ontario, Alberta & British Columbia).
- 762 laboratory detections of influenza were reported, proportion of positive tests was 22.5%.
 The proportion of positive detections for influenza B declined and increased for influenza A compared to the previous week.
- The ILI consultation rate was within the expected levels for this time of year. 48 influenza or ILI outbreaks were reported: 27 in long-term care facilities, 5 in schools, 4 in hospitals and 12 in other settings.

International:


• United States: On April 12, the CDC reported one new case of human infection with a novel influenza A virus in a child in Utah. The child was infected with an influenza A (H3N2) variant virus similar to those identified in the 12 human infections that occurred between July and November 2011. The child has recovered and contact with swine in the week preceding onset of the child's illness was reported. No such cases have been reported in Canada.

1) Influenza Laboratory Data¹

- Continued increase in percent positive lab results (since week 11).
- 39 influenza detections were reported during that period.
- Since the beginning of the season, 164 positive influenza detections have been reported; 24 were influenza A (H1N1)pdm09 (15%), 15 were influenza A (H3)(9%) and 125 were influenza B viruses(76%).

¹ Surveillance specimens are submitted by recruited New Brunswick Sentinel Practitioner Influenza Network (NB SPIN) practitioners, which are comprised of 7 sites in Emergency Rooms, 5 sites in Family Practice, 3 sites in First Nations communities, 1 site in a Nursing Home, 3 sites in Universities and 8 sites in Community Health Centers. Diagnostic specimens are submitted by physicians in the community/hospital setting. Influenza laboratory data is comprised of results from surveillance and diagnostic specimens. All laboratory specimens are tested using a real-time PCR assay, which is a rapid detection method designed for detection of all known variants of influenza A and B. All laboratory-confirmed cases are reported for the week when laboratory confirmation was received.



2) ILI Consultation Rates³

- During week 14, the ILI consultation rate was 0.0 consultations per 1,000 patient visits, and is below the expected levels for this time of year.
- During week 14, the sentinel response rate was 21% for the FluWatch sentinel physicians and 39% for the NB SPIN practitioners. (3 FluWatch and 7 NB SPIN)

³ A total of 32 practitioner sites (14 FluWatch sentinel physicians and 18 NB SPIN sites) are recruited this season to report the number of ILI patients and total patient consultations one day during a reporting week.


