

# WEEKLY NEW BRUNSWICK INFLUENZA REPORT

Reporting period: November 11 to November 17 2012 (week 46)

## Summary

### In New Brunswick, influenza activity at typical inter-seasonal levels

#### New Brunswick:

- There have been no positive influenza detections during week 46.
- The ILI consultation rate was low and was within the expected range for this time of year.
- No ILI or influenza outbreaks were reported.

### Canada:

- Influenza activity in Canada increased compared to the previous week with more regions reporting sporadic and localized activity.
- 151 laboratory detections of influenza were reported, proportion of positive tests was 6.0% in week 46.
- The ILI consultation rate was within the expected levels for this time of year. Nine influenza outbreaks were reported, 6 in long-term care facilities and 3 in other settings.

### International:


• From September 2012 to date, 6 reports have been received of human infections with a novel coronavirus (nCoV), 4 from Saudi Arabia and 2 from Qatar. There have been 2 fatal cases. Two of the most recent cases in Saudi Arabia are considered to be epidemiologically-linked as they are from the same family and live in the same household. Investigation is continuing in order to identify the source, the route of transmission and changes with the virus.

### 1) Influenza Laboratory Data<sup>1</sup>

- Influenza activity has continued to be typical inter-seasonal levels.
- No influenza detections were reported during that period.
- Since the beginning of the season, one influenza positive lab detection has been reported, an influenza A (H1N1)pdm09 virus.

<sup>1</sup> Surveillance specimens are submitted by recruited New Brunswick Sentinel Practitioner Influenza Network (NB SPIN) practitioners, which are comprised of 7 sites in Emergency Rooms, 5 sites in Family Practice, 3 sites in First Nations communities, 1 site in a Nursing Home, 3 sites in Universities and 8 sites in Community Health Centers. Diagnostic specimens are submitted by physicians in the community/hospital setting. Influenza laboratory data is comprised of results from surveillance and diagnostic specimens. All laboratory specimens are tested using a real-time PCR assay, which is a rapid detection method designed for detection of all known variants of influenza A and B. All laboratory-confirmed cases are reported for the week when laboratory confirmation was received.



### 2) ILI Consultation Rates<sup>3</sup>

- During week 46, the ILI consultation rate was 4.04 consultations per 1,000 patient visits, and was within the expected levels for this time of year.
- During week 46, the sentinel response rate was 42% for both the FluWatch sentinel physicians and the NB SPIN practitioners.


