

### WEEKLY NEW BRUNSWICK INFLUENZA REPORT

Reporting period: December 2 to December 8 2012 (week 49)

## Summary

### In New Brunswick, low influenza activity and within expected levels

### **New Brunswick:**

- There have been 7 positive influenza detections during week 49, 6 influenza A (H3) and 1 influenza A (H1N1)pdm09 virus.
- The ILI consultation rate was low and was slightly below the expected range for this time of year.
- Two ILI outbreaks were reported in schools in Region 3 and 5.

#### Canada:

- Influenza activity in Canada continued to increase, one region reported widespread activity, and more regions reported sporadic or localized activity.
- 816 laboratory detections of influenza were reported, proportion of positive tests was 17.8% in week 49.
- The ILI consultation rate was within the expected level for this time of year. 22 influenza outbreaks were reported, 12 in long-term care facilities, 5 in schools and 5 in other settings.

### International:


 United States: One new human infection with an influenza A (H3N2) variant virus was reported during week 49 in Minnesota. Patient has fully recovered and close contact with swine in the week preceding illness was reported. From July 12 through December 8, 2012, a total of 312 infections with variant influenza viruses (308 H3N2v viruses, 3 H1N2v viruses and 1 H1N1v virus) have been reported in 11 states.

# 1) <u>Influenza Laboratory Data<sup>1</sup></u>

- Influenza activity is at low levels.
- 7 influenza detections were reported during that period.
- Since the beginning of the season, 10 influenza positive detections have been reported, 2 influenza A (H1N1)pdm09 and 8 influenza A (H3) viruses.

Surveillance specimens are submitted by recruited New Brunswick Sentinel Practitioner Influenza Network (NB SPIN) practitioners, which are comprised of 7 sites in Emergency Rooms, 5 sites in Family Practice, 3 sites in First Nations communities, 1 site in a Nursing Home, 3 sites in Universities and 8 sites in Community Health Centers. Diagnostic specimens are submitted by physicians in the community/hospital setting. Influenza laboratory data is comprised of results from surveillance and diagnostic specimens. All laboratory specimens are tested using a real-time PCR assay, which is a rapid detection method designed for detection of all known variants of influenza A and B. All laboratory-confirmed cases are reported for the week when laboratory confirmation was received.



# 2) ILI Consultation Rates<sup>3</sup>

- During week 49, the ILI consultation rate was 0.0 consultations per 1,000 patient visits, and was slightly below the expected levels for this time of year.
- During week 49, the sentinel response rate was 32% for both the FluWatch sentinel physicians and the NB SPIN practitioners.


